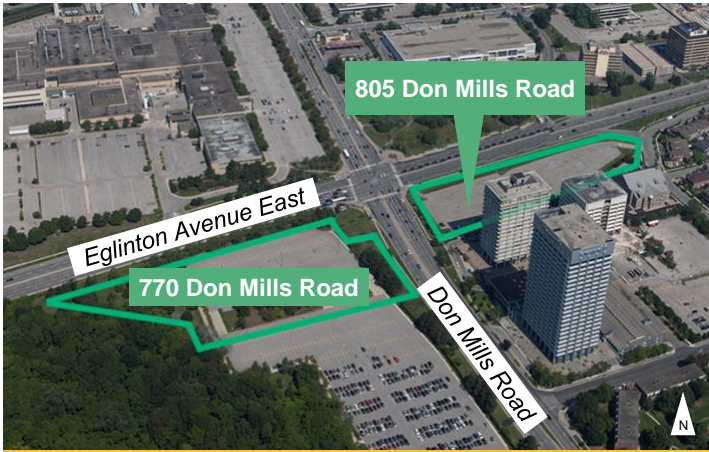




770 Don Mills Road & 805 Don Mills Road Community Consultation Meeting

770 Don Mills Road

The preliminary development concept proposes:

- 3 buildings up to 48 storeys
- Approx. 1,250 residential units
- Approx. 417 affordable rental homes
- A new TDSB elementary school, child care facility, public park, and a public road through the site

805 Don Mills Road

The preliminary development concept proposes:

- 2 buildings up to 48 storeys
- Approx. 805 residential units
- Approx. 268 affordable rental homes
- A new public park, child care facility, a public road, and improvements to the public realm and streetscape
